#### JANUARY 14—THE GOOD NEIGHBOR HEALTH CLINIC

The Good Neighbor Health Clinic is a non-profit free health care facility established in 1992 to offer free primary medical and dental care to the people of the Upper Connecticut River Valley who are in need and lack the resources to obtain adequate care. Their main facility is in White River Junction, Vermont, and they also operate satellite clinics

in Lebanon and Enfield, NH. The Good Neighbor Clinic never charges for its services, and is staffed by medical professionals who volunteer their time and skill. Several members of our congregation have benefitted from the services of the Good Neighbor Clinic, and we also have members who serve as volunteers at the clinic. # **ABOUT MEMBERSHIP**

#### About Membership in the First Universalist Society of Hartland Four Corners

Our congregation is made up of both "members" and "friends," with varying degrees of commitment to our work. Whether you formally join our congregation as a member, or whether you prefer to consider yourself a non-member "friend," you are welcome and encouraged to participate actively in the life of our church community.

#### What it Means to Be a Member of Our Congregation

Members of our congregation are those who have made a formal commitment to our community by "signing the book"—declaring their commitment publically by setting their signature to our book of membership, in consultation with our minister.

According to our by-laws, membership is available to all those over 18 years of age who:

- "State that they are in agreement with the purposes of our Society and of the Unitarian Universalist Association"
- Are willing to participate in the work and activity of our community
- Are willing to support our work with their time, energy, and resources

There is no set time frame or specific guideline about when you might choose to become a member, but we do ask you to spend some significant time learning about the mission, history, theology, practices, and culture of our congregation through regular attendance, through our "Introduction to Unitarian Universalism" sessions, and/or through conversations with our minister and other leaders of our community.

Members of our congregation can serve in volunteer leadership positions on our governing board, board of trustees, and our committee on ministry, and can vote in congregational meetings (please note that our by-laws require that to vote to amend our by-laws, or to call or dismiss a minister, an individual must have been an active member of the congregation for at least a full year).

Members are entitled to the services of the minister and the use of the church building for rites of passage (weddings, memorial services, child dedications, etc.) at no cost. Members are formally considered "Unitarian Universalists" by the Unitarian Universalist Association, and receive Unitarian Universalist World magazine at no additional cost.

#### What it Means to Be a "Friend" of Our Congregation

Friends of our congregation are welcome to participate in nearly all aspects of the life of our church, including attending programs and services, serving on committees, leading layled worship, and, of course pledging to support our work financially.

They are not eligible to vote in congregational meetings, or to serve on our governing board, trustees, or committee on ministry. They can, however, serve in other leadership roles in church life, including serving as a champion of an activity.

#### "Active" Membership Status, Moving Away, and other Concerns

We ask members of our congregation to maintain their "active" status through ongoing participation and/or support of our congregation. Members who discontinue participation or support of our congregation, for whatever reason, may be listed in our records as "Inactive" and may need to reactivate their membership in order to vote or to hold a leadership position.

Even members that move out of town are welcome to remain as "active" members, through regular financial or other support and through making an effort to stay connected in some fashion with our congregation.

For those who move either to or from our region, it's good to know that Unitarian Universalist tradition allows individuals to be members of more than one congregation, provided the member meets the requirements set forth by each congregation. Under the same stipulation, we are also open to members who continue to hold ongoing membership in communities identified with other faith traditions.

Youth who are active participants in our congregation are welcome to become members after their 18th birthday, and can be considered active members during their young adult years, even if their work or school commitments leave them unable to participate regularly in the life of our congregation. We do not have a formal "confirmation" program for our youth. Youth considering membership should speak with the minister.

#### **BY-LAWS OF THE FIRST UNIVERSALIST SOCIETY**

HARTLAND, VERMONT (As revised 6/9/91, 2/2/92, 8/28/92, 7/15/01, 1/18/03, 6/1/06, 12/2/12, 12/7/2014, 12/6/2015)

#### Proposed changes 1/14/2017 Bold: Proposed new language <u>Underlined Italics</u>: Language to be changed/removed

#### ARTICLE I – NAME

The name of this organization shall be The First Universalist Society of Hartland (Unitarian Universalist). Wherever the word "church" or "society" is used in these by-laws, or their amendments, it shall signify the legal organization of this church as herewith established; and the phrase "a vote of the church" or any other similar phrase, shall mean a vote of the members of the congregation who have attained the age of 18 years comprising the church at any duly called meeting.

#### ARTICLE II – PURPOSE

The purpose of this organization is the study and practice of liberal religion in freedom and fellowship.

#### ARTICLE III - WELCOMING

This church affirms and promotes the full participation of all persons in all our activities and endeavors including membership, programming, hiring practices, and the calling of religious professionals, without regard to race, color, gender, physical or mental challenge, affectional or sexual orientation, class or national origin.

#### ARTICLE IV – AFFILIATION

This church is a member of the Unitarian Universalist Association and the Northern New England District thereof, and the Vermont-Quebec Universalist Unitarian Convention, and regards itself as pledged to foster and extend the interests of Unitarian Universalism.

#### ARTICLE V – MEMBERSHIP

<u>Section 1-</u> Any person eighteen years of age or over, who states that **they are** (*he or she is*) in agreement with the purposes of this society and of the Unitarian Universalist Association and who will agree to abide by these by-laws may become a member by signing the parish book.

<u>Section 2-</u> All members of the church at the time of the adoption of these by-laws shall continue as members of this organization.

<u>Section 3-</u> After officially joining the society by signing the parish book, active membership is maintained by identifiable support and participation in congregational life.

Section 4- If a member has not participated in the society's life for a period of one year, the member  $(\underline{s/he})$  may be placed on inactive status by vote of the Governing Board. The Clerk of the society shall review the

membership rolls annually The Governing Board will make every effort to contact members before placing them on inactive status, so as to clarify their desired status. Inactive members may not vote at society meetings and may not hold offices.

<u>Section 5-</u> Inactive members may reactivate their status by written request to the Governing Board. Reactivated members may not vote on

- (a) Dismissal of the minister
- (b) Dissolution of the legal society
- (c) Amendments to the by-laws

for a period of one year after their reactivation takes effect.

<u>Section 6-</u> Membership of those on inactive status may be terminated by the Governing Board after a period of two years. The Governing Board will make every effort to contact inactive members before terminating their membership, so as to clarify their desired status.

<u>Section 7-</u> Conflicts arise from time-to-time and it is expected that all members will act in accordance with the Society's Covenant. The membership of any member whose behavior violates the principles of this society or the Unitarian Universalist Association may be terminated by a two-thirds (2/3) vote of the Governing Board.

#### ARTICLE VI - VOTING POWERS

Section 1- All active members of this church eighteen years of age or over may vote at all meetings and on all questions except

- (a) Dismissal of a minister, or
- (b) Dissolution of the legal society, or
- (c) Amendments to these by-laws.

In these cases only those who have been legal voting members of the church for one year or more shall vote.

Section 2- A proxy vote shall not be honored in any legally called meeting of this organization.

#### ARTICLE VII - THE MINISTER

<u>Section 1-</u> To be eligible for election a candidate for minister must be enrolled in a recognized theological school or hold fellowship in the Unitarian Universalist Association, or be in the process of acquiring Fellowship status, and must thereafter maintain fellowship in such organization.

<u>Section 2-</u> A two-thirds (2/3) vote of the legal membership of the church shall be necessary to call or dismiss a minister, such vote to be taken at a legally called meeting of the church.

Section 3- The minister shall have freedom of the pulpit.

<u>Section 4-</u> The minister shall be responsible to the church through the Governing Board, which shall fix the minister's salary and terms of incumbency which terms shall be set forth in a written agreement.

<u>Section 5-</u> The minister shall have control of all religious services and of such other activities of the church as the church or its Governing Board shall from time to time determine. The Minister shall be encouraged to participate in civic and community affairs. The minister shall keep a record of all dedications, baptisms, marriages, funerals and other services performed by the church during **the Minister's** (*<u>his or her</u>*) pastorate, such record to be the permanent property of the church.

<u>Section 6-</u> The minister shall be a member of all committees of the church, but without a vote. The Minister may be asked not to attend any society meeting at which **the Minister's** (*<u>his or her</u>*) tenure or salary is to be discussed.

## ARTICLE VIII-OTHER EMPLOYEES (For further discussion and later amendment)

#### ARTICLE IX- THE GOVERNING BOARD

<u>Section 1-</u> The Governing Board of this church shall consist of seven members elected from and by the church membership, all of whom may vote on all questions at all meetings of the said Governing Board at which they are present.

<u>Section 2-</u> The Governing Board members shall be elected for a term of three years each on the following rotation: two members being elected at the first of three annual meetings, two members being elected at the second of three annual meetings and three members being elected at the third of three annual meetings with this cycle repeating. A person who has served for six full years shall not be eligible for reelection as a Governing Board member until after the expiration of one church year, except by vote of the Nominating Committee and approval by the Governing Board.

<u>Section 3-</u> A vacancy in the Governing Board shall be filled by appointment by the Governing Board, such appointee to hold office until the next legal meeting of the church.

<u>Section 4-</u> The Governing Board shall promote the working programs of the church. It shall receive and act on the reports of the minister and the chairs of committees and boards and shall disseminate those reports to the membership of the church at annual and semiannual meetings. It shall be charged with the business of the church during the interval between annual or special meetings of the church body. It shall make all decisions concerning financial disbursements. It shall approve the annual budget prepared and submitted by the Finance Committee. It shall approve and act on long and short term financial goals proposed by the Finance Committee. In the event that other boards or committees cannot be appointed due to lack of volunteers, the Board shall be responsible for filling those vacancies or otherwise ensuring the continuation of the necessary functions of those boards or committees.

<u>Section 5-</u> The Governing Board shall meet at least nine times annually on a regular basis, which it shall determine. The President may call special meetings from time to time by notifying all of the members a reasonable period of time in advance. The Governing Board or any member may participate in meetings by telephone or electronically if necessary.

Section 6- A quorum of four shall be necessary for the Governing Board to legally conduct business.

Section 7- Governing Board meetings are open to all society members except when the Governing Board shall be in Executive Session. The Clerk shall publicize all meetings

<u>Section 8-</u> The service on the Governing Board by any member whose behavior violates the principles of this society or the Unitarian Universalist Association may be terminated by a two-thirds (2/3) vote of the remaining members of the Governing Board.

#### ARTICLE X- OFFICERS AND THEIR ELECTIONS

<u>Section 1-</u> Officers of the church shall be elected from and by the elected members of the Governing Board at the Board meeting immediately following the annual meeting of the church. Each officer shall be elected for a term of one year.

<u>Section 2-</u> The officers of this church shall be the President and Vice-President of the Congregation, the Treasurer, and the Clerk. Said officers shall constitute the Executive Committee of the society.

<u>Section 3-</u> All officers appointed by the Governing Board shall assume office immediately upon the adjournment of the meeting in which they were elected or appointed.

<u>Section 4-</u> All officers elected or appointed by the Governing Board shall be from the legal voting membership of the church.

<u>Section 5-</u> A vacancy in any office shall be filled by appointment by the Governing Board, such appointees to hold office until the next legal meeting of the church.

<u>Section 6-</u> The Governing Board may appoint an assistant treasurer, an assistant secretary, and such other officers as in its judgment may be necessary. These additional officers do not need to be members of the Governing Board.

#### ARTICLE XI- DUTIES OF THE OFFICERS

<u>Section 1-</u> The President of the Congregation shall be the chair of the Governing Board and, in the absence of an elected moderator, shall preside at all meetings of the church. The President of the Congregation shall be the chief administrative officer of the church. The President shall sign all contracts, deeds, mortgages and other instruments in the name of the church when authorized to do so by vote of the Governing Board or by a meeting of the church.

<u>Section 2-</u> The Treasurer shall keep full and accurate accounts of receipts and disbursements in books belonging to the church and shall deposit all money and other valuable papers in the name and to the credit of the church in such places as are designated by the Governing Board. The Treasurer may designate an Assistant Treasurer to perform the duties of collector and/or other duties as defined by the Treasurer with the approval of the Governing Board.

<u>Section 3-</u> The Clerk shall give notice of all meetings of the church, shall record minutes of all meetings of the church, shall keep on file the minutes of all meetings of the church, all records and statistics and all books, papers and reports of organizations, and perform such other duties as are incidental to the office. The Clerk shall serve as Secretary of the Governing Board.

Section 4- The Vice-President shall substitute for the President as needed.

<u>Section 1-</u> The Board of Trustees shall consist of three at large members. The President of the congregation, the Treasurer and the Minister shall be ex-officio members without vote.

<u>Section 2-</u> The Trustees shall be elected for a term of three years each, one Trustee being elected at each annual meeting. A person who has served for a term of three full years shall not be eligible for reelection as a Trustee until after the expiration of one church year, except by approval of the Governing Board.

<u>Section 3-</u> The Trustees shall meet at least quarterly. They shall designate a Trustee as a liaison between the Trustees and the Governing Board. After the Board of Trustees' quarterly meetings, the liaison Trustee shall attend the next Governing Board meeting with a written report to be filed with the Clerk.

<u>Section 4-</u> The Board of Trustees shall be charged with the investment and reinvestment of the financial assets and trust funds of the church. It shall be responsible to the Governing Board, which shall make all decisions concerning the disbursement of financial assets and trust funds.

Section 5-

- a. The Trustees shall make available the interest from restricted and unrestricted funds to the Governing Board, which shall decide whether to spend or reinvest such interest. The interest from restricted funds shall only be spent in compliance with the restrictions.
- b. The Trustees shall provide funds, as requested by the Governing Board, from the unrestricted capital assets of the church.
- c. The Trustees shall provide funds, as requested by the Governing Board, from restricted capital assets of the church when the proposed expenditures comply with the restrictions.
- d. The Trustees at the request of the Governing Board, shall petition the church, at a duly called and warned meeting, to liquidate capital assets from restricted funds, or to spend the interest from such restricted funds, when the proposed expenditures do not comply with the restrictions. A two-thirds (2/3) vote of members present and voting shall be required to so liquidate capital assets from restricted funds. or to spend the interest from such restricted funds, when the expenditures do not comply with the restrictions. Upon the liquidation of restricted capital assets the Governing Board shall establish a capital endowment fund drive to restore the restricted capital assets to its previous level.

#### ARTICLE XIII – COMMITTEES

<u>Section 1-</u> The Governing Board shall have the power to appoint such ad hoc committees from time to time as may be necessary for the effective operation of the church provided, however, that such functions do not fall specifically within the area of the several committees whose functions are established by these by-laws.

<u>Section 2-</u> Each committee shall consist of at least three members chosen (from volunteers) or appointed by the Governing Board. The chairperson shall be elected at the first meeting called by the outgoing chair, following the Annual Meeting.

<u>Section 3-</u> The committees will be responsible for certain basic functions of the church. Those functions shall include but are not limited to: ministry, finance, property, worship, and membership and may include other functions as deemed necessary by the Board.

<u>Section 4-</u> When notified that the position of minister will become vacant, the Governing Board shall appoint a Ministerial Search Committee, consisting of not less than three nor more than five members. The purpose of this committee is to conduct a search in a manner consistent with Unitarian Universalist Association

recommendations and the desires of the congregation. Its tenure shall continue until a permanent minister is settled.

#### ARTICLE XIV - BUSINESS MEETINGS

<u>Section 1-</u> The Annual Meeting for the transaction of the business of this church shall be held on **a Sunday** in January on a date and in a location determined by the Board. (on the second Sunday in January. The location of both meetings will be set by the Governing Board.)

#### **Remove Temporary Section:**

(Section 1a- The first January annual meeting will take place in January 2017. A transitional meeting will be held in 2016 to allow for a legal annual meeting of the society in that calendar year, at a time and with an agenda determined by the Governing Board.)

<u>Section 2-</u> Special meetings may be called by the Governing Board or upon the written request to the clerk of at least five legal voting members of the church.

<u>Section 3-</u> It will be the first item of business after the convening of any church meeting (<u>by the minister</u>) to elect a moderator who shall chair the meeting. All meetings shall be conducted in accordance with *Roberts Rules of Order*, Revised Edition.

<u>Section 4-</u> Notice of all business meetings shall be posted in a conspicuous place on or within the church building at least ten days before the date of the meeting. This period shall include two Sundays. Notice shall also be published in the church paper, or in the event that none is being published, shall be mailed to each member whose address is known at least ten days before the date of said meeting.

<u>Section 5-</u> At least one-quarter (1/4) of the total active membership of the church shall constitute a quorum for regular business; however, three-fourths (3/4) of the total legal membership shall be required for a vote on the dissolution of the legal society.

#### ARTICLE XV- DISSOLUTION

In the case of dissolution of this church, all its property, both real and personal, after paying all just claims upon it, shall be conveyed to, and vested in, the Vermont-Quebec Universalist Unitarian Convention or its successors or assigns.

#### ARTICLE XVI – AMENDMENTS

This constitution and these by-laws may be amended by a two-thirds (2/3) vote of the members present and voting at the annual business meeting of the society, provided that notice of the proposed amendment has been indicated in the warning for such meeting. Amendments may be proposed by a previous annual meeting, by the Governing Board, or by the written application of at least five members of the church to the clerk provided such notice is received in time for inclusion in the regular warning.
